PER CURIAM. In view of the fact that the Missouri Supreme Court has declared Missouri's statute *708 of workers' compensation to be constitutional, the Court of Appeals of this Circuit held that "the ultimate disposition of this case will be of little importance" to the state court or anyone else (161 F. 2d 107, 110) and denied certiorari. We granted certiorari to review the construction of the Court of Appeals and, on further consideration, we granted the writ. 352 U. S. 968. The judgment of the Missouri Supreme Court is affirmed. It is not for the federal courts to determine the ultimate disposition of the case or to anticipate a possible result. As this Court has stated, the federal court in "no case has the duty or authority to decide any question of constitutionality...." Spector Motor Co. v. McLaughlin, 323 U. S. 101, 105. See also Massachusetts v. Mellon, 262 U. S. 447, 482. MR. JUSTICE HARLAN took no part in the consideration or decision of this case. The internet security firm Trend Micro reported in February that it had found evidence of an intrusion by the Nippon Telegraph and Telephone (NTT) Co-operative group that had access to information about the country's diplomatic missions. Speaking at a closed door meeting with domestic telecom companies, Hajime Inokuchi, an aide to Prime Minister Shinzo Abe, reportedly told investors that the "cost of data theft" was increasing and the government could potentially implement such measures. Inokuchi is head of a government panel set up in December last year that is looking into countermeasures after a string of cyber attacks by North Korea and a foiled move by the US to target a Japanese TV network with the help of a North Korean hacking group.
